Spectating: Spectating will be available at this competition. Small entry fee payable on the day.

Awards: Medals for 1st to 6th places in all age groups for all events.

- Marshalling: Swimmers must report to the marshalling area a **minimum of 6 heats** prior to their scheduled swim. It is the responsibility of the competing squads to ensure their swimmers report to the marshalling area on time. Swimmers who report late to marshalling may be replaced by reserve swimmers at the discretion of the referee.
- Spare lanes: REN 96 Swim Team reserves the right of spare lanes if available.
- Withdrawals: Withdrawals will be processed up until 45 minutes prior to the start of each session. However, no refunds will be provided for any withdrawals that are submitted after Friday 29th May 2026.
- Refunds: **IMPORTANT-** Clubs should not send finances with entries. REN 96 will invoice clubs after entries are confirmed thus eliminating the need for refunds.
- Reserve Swims: Reserve swimmers are expected to arrive at marshalling at the beginning of each event where swims will be allocated appropriately. Reserve swimmers who do not wish to be considered should be withdrawn on the day.
- Safeguarding : REN 96 are fully aware of our Safeguarding responsibilities and take these very seriously. Site specific information about arrangements to ensure the safeguarding of swimmers will be provided to all participating clubs in advance of the meet. **Please note that coaches and Team Managers should enter the poolside via the spectators gallery and not via the changing rooms.**
